



**Subject: Reopening of school for classes I to V, VIII, X & XII from Monday, 02 August 2021 - Reg.**

Dear parents/guardians

It has been more than a year since I interacted with you all. The Covid-19 pandemic ensured that we all stayed at home and followed the Covid protocol, in order to stay healthy and safe. However, during the year we tried to ensure that our children did not lose out in the learning process. Classes were conducted online and tests and examinations too were held. By the grace of the Almighty, proper medical care and vaccinations, things have improved and we are gradually moving towards a new normal.

Further, as per the notification of the School Education Deptt., Govt. of Chhattisgarh we have scheduled to reopen school from Monday, 02 August 2021 for classes I to V, VIII, X & XII. I would like to inform you the following:

1. It will not be mandatory for the students to attend school as attendance will be optional.
2. **The teachers will start using the smart-boards for teaching and will share screen through zoom app for those who wish to attend classes online.**
3. It is upto the parents to send their ward(s) to the school or not.
4. The students may attend the classes online if they wish to do so from their residences as is being done now.
5. Students will be called on alternate days i.e. students with Odd roll numbers may attend class on Monday, Wednesday and Friday and those with Even roll numbers may attend class on Tuesday, Thursday and Saturday.
6. The timings of the classes I to V will be from 8:00 a.m. to 11:00 a.m. and that of VIII, X & XII will be from 7:00 a.m. to 12:30 p.m.
7. **The students of classes Nursery, Prep, VI, VII, IX & XI will continue to attend classes online.**
8. If the parents wish their ward(s) to attend school, then their ward(s) are expected to wear mask, carry sanitizer and not to share their personal belongings with the other students.
9. The school management will ensure that the social distancing norms are followed among students and staff during the school hours and each classroom is sanitized every day after school hours.
10. The school management proposes to start bus facility from day one i.e. 02 August, 2021 and it is expected that there may be some issues for a few days depending on the number of bus commuters attending the school. Bus route will be uploaded on our school website. The school will not charge bus fee till the student starts availing the bus facility. However, it is expected that parents/guardians will drop and pick-up their ward(s) those who would like to attend offline classes.
11. The school management respects the concerns of the parents/guardians towards their ward(s), however, at the same time they must have a positive approach towards reopening of school.

If you would like to send your ward(s) to school from Monday, 02 August 2021 onwards, then you will be required to give your written consent in the pro forma attached which your ward will carry while coming to school and hand it over to his/her respective class teacher. An advance copy (preferably image file) can be posted in the class WhatsApp group.

To conclude, I would like to inform the esteemed parents and guardians that their wards may be dressed in sober, civil dress (along with duly corrected I-card), in case their uniforms are not available for the week starting from 02 August 2021. However, from the following week uniform should be worn.
